

Terms and conditions overview

What is 997 Business?

997 Business is a collaborative venture by photographer Ray Jones and website designer Eric Davies (trading as Raymond Jones Images and DoodlyDog respectively).

The 997 Business package will deliver 20+ quality photographs, two short videos and a multi-page WordPress website all for the price of £997.

Additional images, videos and website features (such as ecommerce) can be purchased separately if required.

How does it work?

An initial 'get to know you' meeting will be arranged to discuss your project ideas. The meeting will probably be held over Zoom and will ideally include Ray, Eric and yourself/selves, but separate meetings will be arranged if necessary.

If, after the meeting/s, we agree to proceed with your project, then you will be asked to read, sign and return contracts / terms and conditions for the services being provided - separately - by Ray and Eric.

You will also be invoiced for a non-returnable deposit of £400.

Photos

Once payment is received, you will be invited to arrange a photo shoot with Ray, at a mutually agreed location. (Please note that if you are more than 50 miles from Ray's home in Chirk, North Wales, then additional travel charges may apply.)

It is likely that scores of photos will be taken during the session, with Ray then selecting 20 plus of the best for you to use on your website and for social media posts etc.

The two videos will be primarily intended for use on your website and - if required - will be limited to about 15 seconds each. You will also be free to use them elsewhere if you wish.

Website

Meanwhile, Eric will start work on the website side of things (domain registration / transfer, hosting, initial design ideas etc).

The site will be created in consultation with you and will be tested on various devices and browsers before being launched.

Once it is launched, you will be invoiced for the balance of £597 plus any additional charges agreed.

If a domain was registered on your behalf, or transferred to Hostinger, then you will be liable to pay the cost of the registration and of any renewals (Eric does not charge for finding domain names or for registering or renewing them; you will pay only the cost of the domain itself).

If you take up the offer of free website hosting, your quality cloud-based from Hostinger will last for 12 months, after which you will be invited to renew at the prices then being charged by Eric (currently £100 for one year, £180 for two years, £240 for three years).

Note that if you decide not to continue with Hostinger hosting, then you may need to transfer or redirect your domain to an alternative host - which might adversely impact the performance of your website.

After the site is launched, Eric will monitor it once a month for a year, checking for updates required to WordPress plugins, themes etc and to make sure it is loading as fast as expected.

Once the initial year's maintenance ends, you can either look after the site yourself or pay for it to be managed (current charges are £100 for a year's maintenance only or £25 per month / £240 per year for maintenance plus an hour's worth of content updates).

Contracts
